
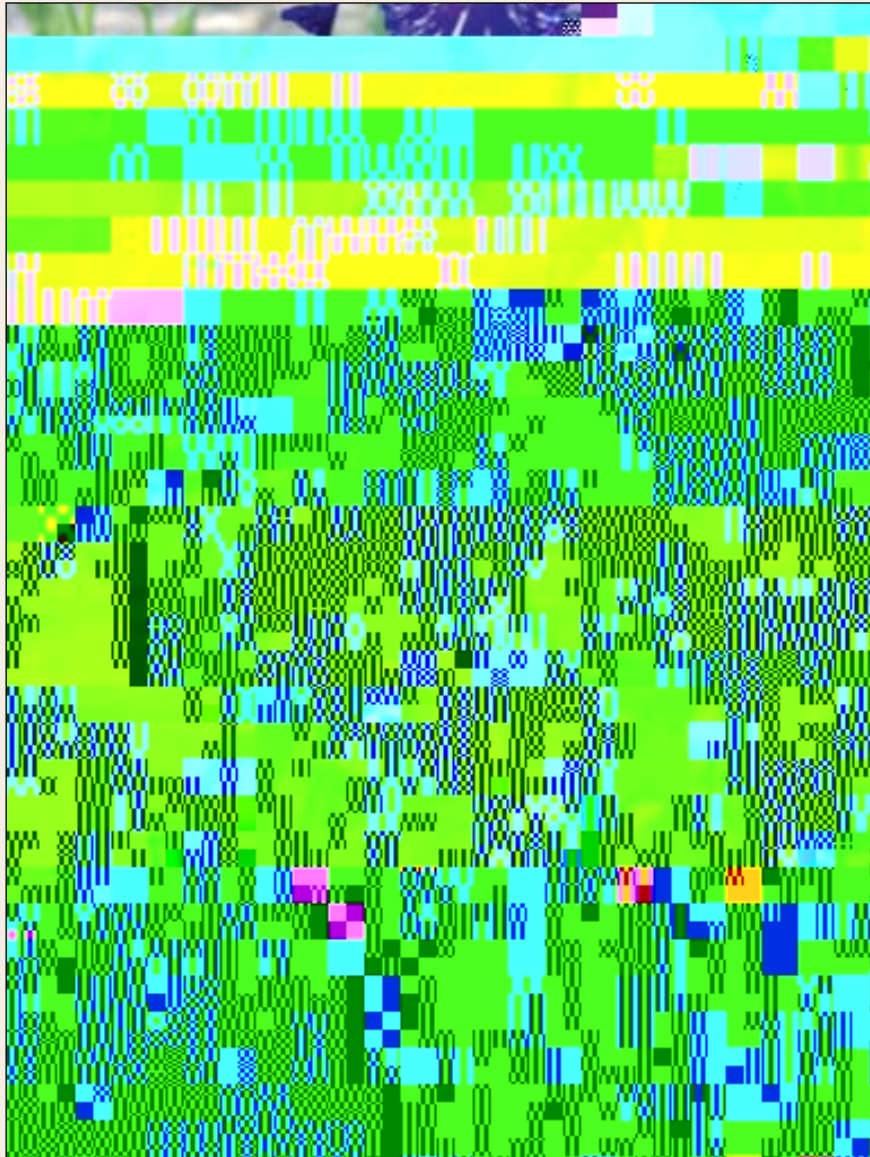

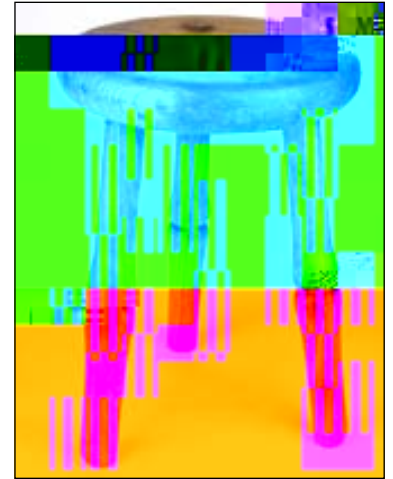

A Sturdy Stool

There are three ways to give to NWU. These gifts form the legs of the “stool” on which the university stands. When all three pillars are strong, Nebraska Wesleyan has the stable financial foundation it needs.

Annual Fund Gifts

NWU cannot exist without a strong Annual Fund. It provides the basis for operating NWU, from salaries to maintenance to scholarships. Annual gifts to NWU are needed in lieu of the tax dollars that support public institutions.

Planned Gifts

Planned gifts are gifts arranged now with assets used later. Examples include wills, trusts, gift annuities, retirement assets, and life insurance policies. Some establish funds during their lives, supplementing them with estate gifts.

Unrestricted/Restricted and Endowed/Expendable Gifts

Unrestricted gifts benefit the university generally. Restricted gifts designate funds for specific programs. These can be gifts of cash, securities, stock, real estate or other assets.

Endowed funds are invested, and only the income is spent on their designated programs. In contrast, expendable funds are spent over the shorter term.

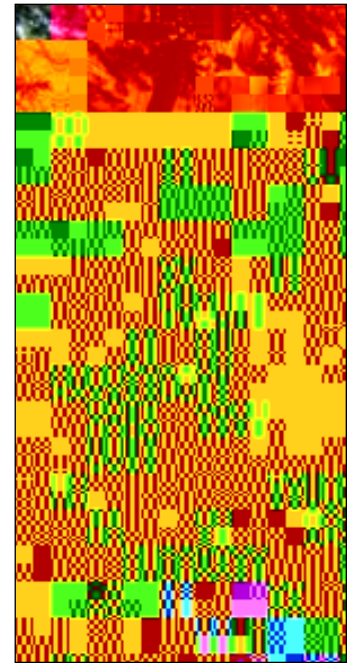
Named endowed or expendable funds may be unrestricted. Such funds help the university meet its changing needs.

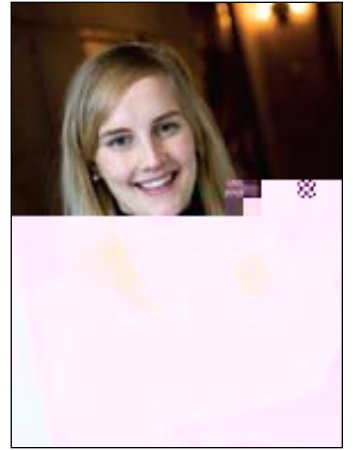

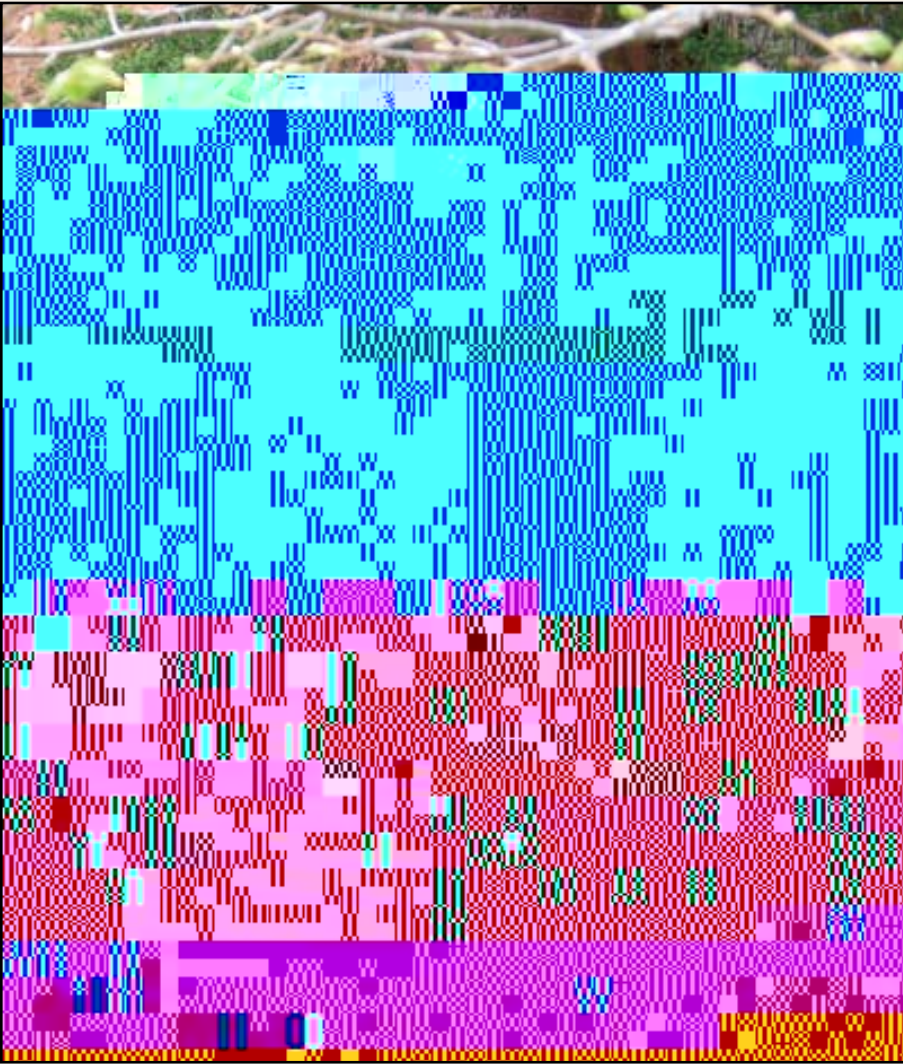

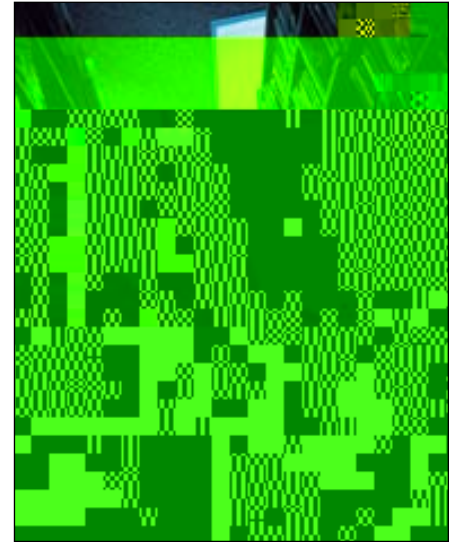


Current Giving

For everyone seeking to change their status in life and build something better for themselves, a good education is the key. It allows people from all walks of life to compete for opportunities and contribute meaningfully to society.

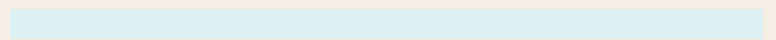
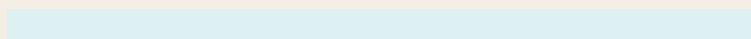
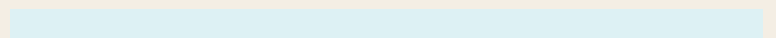
Education can be the great equalizer when it's accessible to everyone with the drive and discipline—and not just those with the financial means—to pursue it.
